# MOUNTAIN VIEW APARTMENT RULES and PROCEDURES

## RENT / CONTRACTS

1. Rent must be paid in full before occupancy is allowed.
2. Students receiving financial aid must provide proof of aid and a parent guaranty form in order to receive an extension on the rent due date.
3. If extension is granted, payment must be received by the date agreed upon or the following late fees will be assessed: \$10.00 the first day + \$2.00/day after.
4. If students decide to leave for any reason (marriage, mission, etc.) before the end of their lease, they are responsible to sell their contracts (not the manager). If contracts are not sold, students are still liable and financially responsible for the full terms of their contracts.
5. Cancellations after July 15, 2010 will result in forfeiture of deposit. After July 15, 2010, students are responsible and liable for full compliance with the lease agreement.

## TENANTS

1. Alcoholic beverages, tobacco, or illegal drugs cannot be possessed or consumed on the premises.
2. No loud noise (TV's, stereos, etc.) is allowed after 10:00 p.m. or before 8:00 a.m.
3. No fireworks, firearms, air guns, knives, or weapons of any kind are allowed on the premises.
4. Residents must provide a twin-bed mattress cover for their use.
5. Tenants are not permitted to access the roof of the building.
6. Residents are responsible for the cost to repair items damaged or broken by abuse or misuse.
7. Residents are responsible for condition of furniture and may not remove furniture from the apartments. Any abuse of furniture will result in assessments.
8. All light bulbs not working at the end of the lease must be replaced by tenants.
9. BBQ grills are permitted on grass areas only.
10. Garbage cans or sacks may not be stored on walkways or porch areas. Garbage must be taken out regularly.
11. Bicycles may not be taken into apartments and instead must be stored in the bike rikes in the back of the premises.
12. Animals are not permitted at any time either inside or outside of the complex.

## GUESTS

1. Guests must leave the apartment by curfew each night. Curfew for guests is midnight Sunday thru Thursday. Friday and Saturday's curfew is 1:30 a.m.
2. Guests of the opposite sex are not permitted in the bedrooms at any time for any reason.
3. All overnight guests must pre-register with the manager; overnight guests of the opposite sex are prohibited.

## VEHICLES / PARKING

1. Residents shall park in assigned locations only (parking lot / front of complex).
2. Vehicles are not allowed on the lawn area for any reason.
3. Inoperable vehicles are not permitted to remain in the parking areas.
4. Residents may not perform major vehicle repairs on complex property.

## MISCELLANEOUS

1. The management or owner is not responsible for theft or loss or damage to articles located on the premises.
2. The owner and management reserve the right at their discretion to establish any and all apartment rules and policies concerning the Mountain View Apartments and to issue and publish such rules and policies as they deem necessary.
